- (e) To sell, mortgage, charge, lease, hire, invest or transpose the Trust investments/properties.
- (f) To open Bank account and to deal with the Trust fund or any part thereof as the Trustees may consider necessary or desirable.
- (g) To raise additional funds for augmenting the corpus of the Trust Fund, it necessary through appropriate programmes, to support the Trust Objects.
- (h) To accumulate the income of the Trust of eventual application to the Trust Objects pending which to invest the accumulation in accordance with the relevant provisions of the Income Tax Act, 1961.

- (xii) Advancement of any other object of general public utility and relief like conducting seminars on educational advancement, providing necessary assistance during natural calamities and such other assistance as may be required from time to time.
12. The trustees shall have all powers as may be required for the proper conduct of the affairs of the trust. The trustees shall have the power to initiate prosecutions and defend legal proceedings as may be reasonable and proper for safeguarding the assets and properties of the trust as also the trust funds and interest, any action taken by such Trustees in this regard shall be deemed to have been taken and ratified by all trustees.
13. The surplus funds of the trust which has not been spent in any year shall be invested in the modes prescribed under relevant sections of the Income Tax Act, 1961 as amended from time to time.
14. The Trustees shall at their discretion, acquire, purchase or sell immovable properties or movable properties in the course of managing of trust. However, any sale of any sale of immovable shall required prior consent of at least three fourth majority of the trustees.
